- 3. The proposals must be submitted in Polish or in English.
- 4. The proposal must be signed by signatories authorised to sign the proposal.
- 5. The offer must include the total net and gross price expressed in PLN or EURO, together with unit prices taken into account.

6. Scope of exclusion of economic operators from the procedure

Excluded from the proceedings shall be those entities who are personally or equity related to the Contracting Entity. Equity or personal relationship is understood as relations between the Contracting Entity or individuals authorised to take commitments on behalf of the Contracting Entity or those acting on behalf of the Contracting Entity in order to prepare and implement the Economic Operator selection procedure, and the Economic Operator, including in particular:

- 1. being a partner to civil law partnership or commercial law partnership,
- 2. holding at least 10% of shares,
- 3. being a member of a supervisory or management corporate body, a holder of general commercial power of attorney (prokurent), an authorised representative,
- 4. being married to, being in direct consanguinity or affinity, second-degree consanguinity or affinity of the second degree collaterally or by adoption or guardianship.
